THE PROBLEM

Navigating procurement complexities without a dedicated team

Brighter Places was grappling with certain procurement challenges. - Reviewing the systems in place to support key processes within procurement, contract management, and supplier payment.
- Assessing the procurement and contract management skills and capabilities across the organisation.
- Completing a gap analysis between current practices and future legislative requirements.
- Preparing a comprehensive report with findings, actionable recommendations, and an Action Plan to support the implementation of proposed recommendations.
